Dear Year 6 Parents/ Carers,

Re: Bike Permits for Lone Cycling

Through our School Travel Plan, we aim to reduce the number of pupils travelling to school by car, making the roads safer and reducing pollution in the environment.

Children in Year 6 must **apply for a bike permit if they plan to leave their bike at school during the day and/or are lone cycling**. Children who cycle with parents and whose parents take their child's bike home will not need a permit. The school will not take responsibility for any loss or damage to your child's bike. Bikes must be chained to the bike rack during the day. This is situated just outside of the Year 5 block.

If your child requests a permit, they will need to read and sign the agreement below. You will also need to sign to show that you agree to your child travelling to school on their bike. As pupils have not been 'Bike4Life' trained, it is important that parents/carers read these guidelines carefully and **make the appropriate decision as to whether they consider their child to be independently 'road safe' and 'cycling proficient'**.

Before a child is granted a Bike Permit, they must show Mrs Sudera that they have an appropriate helmet and reflective wear.
